NEW WATER SERVICE CONNECTIONS SUPERVISORIAL DISTRICT 3 3 VOTES

IT IS RECOMMENDED THAT YOUR BOARD:

As the governing body of the Los Angeles County Waterworks District No. 29, Malibu:

Authorize the Director of Public Works to prepare checks to be paid out of the Waterworks District No. 29, General Fund in the amount not to exceed \$9,000 each for 14 property owners. These payments are necessary to reimburse the property owners for relocating their residential water service lines.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

We are recommending that your Board authorize the Director of Public Works to prepare checks in amounts not to exceed \$9,000 each to 14 property owners (see enclosure) to reimburse them for properly documented costs for relocation of their residential water service lines.

The houses were formerly served by an old, four-inch-diameter water main located in an easement at the rear of the properties. Following a leak in an adjacent section of the line, with your Board's approval, a new eight-inch replacement line was constructed in Pacific Coast Highway at the front of the houses. Before the old line can be abandoned and the project completed, each house's water service must be relocated to the new water meter at the front of the property.

To reduce the District's liability in accessing private properties and being responsible for installation of the new house lines, with the concurrence of County Counsel, we are recommending that the District reimburse the property owner for the cost of service relocation. The not-to-exceed amount of \$9,000 for the relocation of the house lines is based on estimates obtained from contractors.

<u>Implementation of County Strategic Plan Goals</u>

This action is consistent with the County Strategic Plan Goal of Service Excellence. The new water main and water service connections will improve the reliability of water service and the maintenance and operations of the water system in the Malibu area.

FISCAL IMPACT/FINANCING

There will be no impact to the County's General Fund.

The recommended issuing of 14 checks at a maximum of \$9,000 each is not to exceed \$126,000. Sufficient funds for these checks are available in the Fiscal Year 2001-02 Waterworks District No. 29, General Fund (N32).
