**SUPPLEMENTAL LAW ENFORCEMENT SERVICE AGREEMENT
BETWEEN THE COUNTY OF LOS ANGELES
AND THE CITY OF GLENDORA
FOR HELICOPTER PATROL SERVICE
(3 VOTES) (FIFTH DISTRICT)**

IT IS RECOMMENDED THAT YOUR BOARD:

1. Approve the Supplemental Law Enforcement Service Agreement with the City of Glendora for helicopter patrol service, effective upon Board approval.
2. Authorize the Sheriff to provide the requested service.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The purpose of this agreement is to provide the City of Glendora with non-emergent helicopter patrol services as requested by the City of Glendora, effective upon approval of this agreement through August 31, 2005.

Implementation of Strategic Plan Goals

This agreement relates to the Strategic Goals of Organizational Effectiveness and Fiscal Responsibility. By combining resources, the Glendora Police Department and the

Sheriff's Department enhance public safety with helicopter patrol services. All Sheriff's Department costs are fully reimbursed by the City of Glendora.

FISCAL IMPACT/FINANCING

None. There is no net County cost to this agreement. The City of Glendora will absorb the cost of this program. The City of Glendora shall pay the Sheriff's Department for said services according to the appropriate and prevailing billing rates as determined by the Auditor-Controller for the current fiscal year. The estimated cost for the attached agreement is \$10,000 for the remainder of the current fiscal year. This will reimburse the Sheriff's Department for additional operational costs for helicopters and air crews.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

The City of Glendora Police Department desires to obtain additional helicopter service to enhance public safety in the City of Glendora. The Police Department determined that the Sheriff's Department can provide the best and most cost effective helicopter service. On July 30, 2002, the City Council of the City of Glendora approved the Supplemental Law Enforcement Services Agreement with the County of Los Angeles for helicopter patrol service.

This agreement has been approved by County Counsel.

IMPACT ON CURRENT SERVICES

This agreement will improve the quality of law enforcement helicopter patrol service in Los Angeles County by enhancing the interoperability of law enforcement agencies. There is no anticipated impact on current law enforcement services. The Sheriff's Department will deploy additional helicopter patrols to provide the requested service to the City of Glendora.
