RESOLUTION PROHIBITING PARKING OF COMMERCIAL VEHICLES AT CERTAIN SPECIFIED LOCATIONS AND TIMES IN THE AREAS OF PASADENA, WHITTIER, WALNUT PARK, FLORENCE, ALTADENA, AND ATHENS/WESTMONT ALL SUPERVISORIAL DISTRICTS

IT IS RECOMMENDED THAT YOUR BOARD:

- Adopt the enclosed Resolution establishing the prohibition of parking of commercial vehicles with a gross vehicle weight rating of 10,000 pounds or more at the times and locations specified in the enclosed Resolution pursuant to Section 22507 of the California Vehicle Code and Section 15.64.055 of the County Code.
- 2. Instruct the Director of Public Works to post adequate signage along the affected streets in order to reasonably apprise the public as to the nature and extent of the prohibitions.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

On April 30, 2002, your Board adopted an Ordinance amending Title 15 - Vehicle and Traffic of the Los Angeles County Code, wherein Section 15.64.055 of the County Code was amended to allow the County to prohibit or restrict parking of commercial vehicles with 10,000 pounds manufacturer's gross vehicle weight rating or more on designated streets and alleys. A Resolution of your Board is required to designate those streets and alleys where the specific prohibition or restriction is to apply.

<u>Implementation of Strategic Plan Goals</u>

This action is consistent with the County Strategic Plan Goal of Service Excellence by establishing commercial vehicle parking restrictions consistent with current provisions of the Vehicle Code and the County Code and implementing additional commercial vehicle parking prohibitions at the locations specified in the enclosed Resolution's attachments.

FISCAL IMPACT/FINANCING

Sufficient funds are included in the proposed Fiscal Year 2002-03 Public Works Road Fund budget to cover the minor cost of installing the necessary signs and markings advising the public of the parking prohibitions or restrictions. Financing is not required.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

This Resolution complies with provisions of Section 22507 of the Vehicle Code and Section 15.64.055 of the County Code which authorize your Board to prohibit or restrict parking of commercial vehicles on streets or highways specifically identified in the Resolution. The parking of commercial vehicles has adversely impacted the quality of life and/or traffic safety on the streets and surrounding neighborhoods at the specific locations set forth in the enclosed Resolution.

ENVIRONMENTAL DOCUMENTATION

The establishment of these restrictions, including the installation of related traffic control devices required to notify the motoring public, is categorically exempt under Class I-(X)7 of the Environmental Guidelines approved by your Board.

A RESOLUTION OF THE

BOARD OF SUPERVISORS OF THE COUNTY OF LOS ANGELES
PROHIBITING PARKING OF COMMERCIAL VEHICLES
WITH A 10,000 POUND GROSS VEHICLE WEIGHT RATING
OR MORE AT CERTAIN SPECIFIED LOCATIONS AND TIMES
IN THE AREAS OF PASADENA, WHITTIER, WALNUT PARK, FLORENCE,
ALTADENA, ATHENS/WESTMONT

WHEREAS, the Los Angeles County Board of Supervisors is empowered, pursuant to Section 22507 of the California Vehicle Code, to restrict the parking of certain commercial vehicles on County roadways; and

WHEREAS, Section 15.64.055 of the County Code authorizes the restriction or prohibition of parking of commercial vehicles with a gross vehicle weight rating of 10,000 pounds or more on designated public streets and/or alleys; and

WHEREAS, Section 15.64.055 of the Code requires that any such restriction or prohibition be designated by Resolution of the Board of Supervisors; and

WHEREAS, the parking of commercial vehicles has adversely impacted the quality of life and/or traffic safety on the streets and surrounding neighborhoods listed below; and

WHEREAS, the adoption of these commercial vehicle parking restrictions do not apply to commercial vehicles that are parked on designated streets or alleys for the purpose of conducting certain activities permitted under Section 15.64.055 of the County Code.

NOW, THEREFORE, IT IS RESOLVED, that commercial vehicles with a manufacturer's gross vehicle weight rating of 10,000 pounds or more are prohibited from parking between the hours of 10 p.m. and 6 a.m. at the following locations and the penalty for such violation shall be as set forth in this Code:

- 1. On the south side of Huntington Drive between Rosemead Boulevard and Madre Street/Muscatel Avenue (Pasadena area).
- 2. On both sides of Normandie Avenue between Century Boulevard and Imperial Highway (Athens/Westmont area).
- 3. On the east side of Western Avenue between 104th Street and 108th Street (Athens/Westmont area).
- 4. On both sides of Western Avenue between 108th Street and 120th Street (Athens/Westmont area).
- 5. On both sides of Lake Avenue between Altadena Drive and Woodbury Road (Altadena area).

IT IS FURTHER RESOLVED, that commercial vehicles with a manufacturer's gross vehicle weight rating of 10,000 pounds or more are prohibited from parking at any time at the following locations and the penalty for such violation shall be as set forth in this Code:

- 1. East side of Greenleaf Avenue between Reis Street and the Whittier City boundary (Whittier area).
- 2. North side of Leffingwell Road between Imperial Highway and Scott Avenue (Whittier area).
- 3. South side of Leffingwell Road between Imperial Highway and Telegraph Road (Whittier area).
- 4. South side of Leffingwell Road between Stamy Road and Lambert Road (Whittier area).
- 5. Both sides of Mulberry Drive between Calmada Avenue and La Mirada Boulevard (Whittier area).
- 6. Both sides of Mulberry Drive between Guilford Avenue and Laurel Avenue (Whittier area).
- 7. West side of Painter Avenue from 125 feet south of Mulberry Drive to 130 feet north of Walberg Street (Whittier area).
- 8. East side of Painter Avenue from 485 feet south of Mulberry Drive to 40 feet north of Mystic Street (Whittier area).
- 9. Both sides of Valley View Avenue between Telegraph Road and Imperial Highway (Whittier area).
- 10. South side of Lambert Road between Mills Avenue and Scott Avenue (Whittier area).
- 11. South side of Lambert Road between Leffingwell Road and Grayling Avenue (Whittier area).
- 12. North side of Lambert Road between 1st Avenue and Grayling Avenue (Whittier area).
- 13. West side of Santa Gertrudes Avenue from Leffingwell Road to a point 295 feet north of Lemon Drive (Whittier area).
- 14. Both sides of Seville Avenue between Florence Avenue and the South Gate City boundary south of Cudahy Street (Walnut Park area).
- 15. Both sides of Dunlap Crossing Road between Norwalk Boulevard and the Union Pacific Railroad/Metrolink Line west of the San Gabriel River Freeway (Whittier area).
- 16. Both sides of Compton Avenue between Gage Avenue and Florence Avenue (Florence area).

IT IS, ALSO, FURTHER RESOLVED, that commercial vehicles with a manufacturer's gross vehicle weight rating of 10,000 pounds or more are prohibited from parking at any time rather than only from 10 p.m. to 6 a.m. as presently restricted at the following locations and the penalty for such violation shall be as set forth in this Code:

- 1. West side of Carmenita Road from Painter Avenue to 192 feet south of Painter Avenue (Whittier area).
- 2. East side of Carmenita Road from Walburg Street to 240 feet south of Walburg Street (Whittier area).
- 3. West side of Carmenita Road from 912 feet north of Trumball Street to Lanett Avenue (Whittier area).
- 4. East side of Carmenita Road from 100 feet north of Trumball Street to Lanett Avenue (Whittier area).
- 5. North side of Telegraph Road between Gunn Avenue and Mills Avenue (Whittier area).
- 6. North side of Telegraph Road between Valley View Avenue and Chadsey Drive (Whittier area).
- 7. South side of Telegraph Road from 230 feet west of Mina Street to Victoria Avenue (Whittier area).
- 8. South side of Telegraph Road from Bramblebush Avenue to 1,715 feet east of Bramblebush Avenue (Whittier area).
- 9. South side of Telegraph Road from 230 feet west of Chadsey Drive to Corley Drive (Whittier area).
- 10. South side of Telegraph Road from 350 feet east of Leffingwell Road to 200 feet west of Wicker Drive (Whittier area).

IT IS, ALSO, FURTHER RESOLVED, that the Director of Public Works is instructed to post adequate signage along the affected streets in order to reasonably apprise the public as to the nature and extent of the prohibition and the exceptions thereto.
