## FISCAL YEAR 2001-02 YEAR-END BUDGET ADJUSTMENT (All Districts) (4 Votes)

### IT IS RECOMMENDED THAT YOUR BOARD:

- 1. Approve the attached Fiscal Year 2001-02 Year-End Budget Adjustment (BA) for the Department of Health Services (DHS) to increase total DHS surplus funds, as of June 30, 2002, to \$366.9 million in the Hospital Enterprise Fund designation, comprised of a \$55.8 million Fiscal Year 2001-02 actual operating surplus and an existing \$311.1 million Hospital Enterprise Fund designation balance from prior fiscal years; to reallocate certain appropriations and revenues within the Department to align them with Fiscal Year 2001-02 final experience; to transfer the DHS general fund budget units' \$22.7 million surplus to the Hospital Enterprise Fund designation; and to recognize \$6.4 million in funding from the State Emergency Medical Services Authority and increase expenditure authority for the Physician Services Account for the same amount.
- 2. Approve the attached Fiscal Year 2001-2002 Budget Adjustment to reallocate and adjust the appropriation and revenue related to the Personal Assistance Services Council-Services Employees International Union (PASC-SEIU), In-Home Support Services (IHSS) Health Care Plan and to recover \$0.3 million of unused funding from the Department of Public Social Services (DPSS).

### PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION:

The Board's approval of the Fiscal Year 2001-02 Year-End BA (Attachment A) will:

- Increase total DHS funds, as of June 30, 2002, to \$366.9 million in the Hospital Enterprise Fund designation, comprised of a \$55.8 million Fiscal Year 2001-02 actual operating surplus (see Attachment B) and the existing \$311.1 million Hospital Enterprise Fund designation balance from prior fiscal years.
- 2. Reallocate certain appropriations and revenues within DHS to align them with the Department's Fiscal Year 2001-02 final experience.
- 3. Transfer the DHS general fund budget units' \$22.7 million surplus to the Hospital Enterprise Fund designation.
- 4. Align DHS appropriations and revenues related to the PASC-SEIU IHSS Health Care Plan with actual experience, and return to DHS \$0.3 million in surplus program funds from DPSS resulting from slightly lower than expected operating activity.
- 5. Recognize \$6.4 million in funding from the State Emergency Medical Services Authority and increase expenditure authority for the Physician Services Account for the same amount.

#### FISCAL IMPACT/FINANCING

The recommended action adjusts the various Departmental budgets to reflect DHS' actual financial experience for Fiscal Year 2001-02. It also increases the Hospital Enterprise Fund designation balance to \$366.9 million, as of June 30, 2002.

## FACTS AND PROVISIONS/LEGAL REQUIREMENTS:

In accordance with established County practice, this BA transfers the DHS General Fund surplus of \$22.7 million to the DHS Enterprise Fund, which along with the \$33.1 million Enterprise Fund surplus, brings the Department's designation balance to \$366.9 million.
