REQUEST TO DELEGATE AUTHORITY TO THE DIRECTOR OF THE DEPARTMENT OF HEALTH SERVICES TO REIMBURSE VARIOUS PUBLIC-PRIVATE PARTNERSHIP AND GENERAL RELIEF HEALTH CARE PROGRAMS SERVICE PROVIDERS FOR SERVICES PROVIDED IN FISCAL YEARS 2001-02 AND 2002-03

(All Districts) (3 Votes)

IT IS RECOMMENDED THAT YOUR BOARD:

Delegate authority to the Director of Health Services, or his designee, to reimburse the Public-Private Partnership (PPP) and General Relief Health Care (GR) Programs service providers listed on Attachment A for services provided under Board-approved agreements during Fiscal Year (FY) 2001-02 and FY 2002-03. The total cost of the reimbursement shall not exceed \$2,241,517, which is offset by 1115 Waiver funds.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTIONS:

To date, the Department has expended \$59 million on PPP/GR Program services for FY 2001-02. The purpose of the recommended action is to permit the Department to expend remaining FY 2001-02 PPP/GR Program funds on its PPP/GR providers.

In 2002, the Department informed your Board that the estimated FY 2001-02 funding total for PPP/GR services would be \$64 million. However, now that all FY 2001-02 claims for the PPP/GR Program have been submitted, it appears that claims for GR services and PPP specialty were less than anticipated. Therefore, the Department is requesting \$62 million for FY 2001-02, approximately \$2 million less than the \$64 million previously estimated for total PPP/GR Program funding.

In approving the recommended action, the Board is:

- authorizing the Department to reimburse \$2 million of the \$62 million requested for FY 2001-02 PPP/GR services.
- authorizing to the Director of Health Services, or his designee, to reimburse PPP/GR providers for services that were rendered but not reimbursed during FY 2001-02.
- authorizing the utilization of funds that have been under-expended by various providers in FY 2001-02 to achieve 700,000 PPP/GR visits, which is a Department policy goal.

Effective October 1, 2002, the Board approved new agreements for all PPP Program providers. Therefore, PPP agreements in effect at that time were terminated effective September 30, 2002. In terminating those agreements, the Department lost its ability to reimburse the PPP providers through the "look-back" provision in the PPP agreements. That provision permitted the Department, under delegated authority, to reallocate surplus program funds to eligible providers in the event that FY 2001-02 monies remained in the County's PPP Program contract account after all contract obligations for the PPP Program during that Fiscal Year had been satisfied.

Approval of this recommended action will permit the Department to reimburse its eligible providers despite the fact that the agreements that permitted the "look-back" reallocation have been terminated. The reimbursement will total \$2 million because of the Department's available encumbrance within each service type (i.e., primary care, General Relief, dental care). Therefore, 100% of an agency's pending claims may not be fully reimbursed.

FISCAL IMPACT/FINANCING:

The total amount for the expenditures shall not exceed \$2,047,663 for FY 2001-02 and \$193,854 for FY 2002-03. These funds are included in the FY 2001-02 Commitments for FY 2001-02 expenditures and in FY 2002-03 Adopted Budget for FY 2002-03 expenditures.

These funds are offset by the 1115 Waiver.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS:

The PPP Program provides the indigent, low-income, uninsured patient population with medical services throughout Los Angeles County at County and private facility sites. Patients must be at or below 133-1/3% of the Federal Poverty Level (FPL) using the Certificate of Indigency (COI) as self-verification of income to receive services. The cost of services is offset by 1115 Waiver funds.

The recommended expenditures are consistent with the "County Fiscal Year Look-Back Reallocation" provision within the various Board approved agreements which were terminated effective September 30, 2002, in order to establish the new PPP Program, consistent with the federal government's mandate.

County Counsel has reviewed and approved this requested action.

Attachment A provides additional information.

CONTRACTING PROCESS:

The requested delegated authority is necessary to allow the Department to be in compliance with the 1115 Waiver requirement for PPP Program visits in FY 2001-02.

IMPACT ON CURRENT SERVICES (OR PROJECTS):

The Board's approval of this recommendation will ensure that the Department meets the 1115 Waiver requirement of 700,000 PPP Program visits for FY 2001-02.

When approved, the Department requires three signed copies of the Board's action.
