### **TRAFFIC REGULATIONS SUPERVISORIAL DISTRICTS 1, 4, AND 5 3 VOTES**

#### **IT IS RECOMMENDED THAT YOUR BOARD:**

1. Adopt a traffic regulation order establishing a disabled person's parking zone on the west side of Marianna Avenue, between a point 105 feet and a point 125 feet north of Fisher Street, East Los Angeles area (Supervisorial District 1).
2. Adopt a traffic regulation order prohibiting parking for street sweeping purposes, between 8 a.m. and 12 noon, Fridays only, on both sides of Aberly Avenue, between Villa Park Street and Renault Street, La Puente area (Supervisorial District 1).
3. Adopt a traffic regulation order prohibiting parking for street sweeping purposes, between 8 a.m. and 12 noon, Fridays only, on the north side of Villa Park Street, between Lochmere Avenue and Aberly Avenue, La Puente area (Supervisorial District 1).
4. Rescind a traffic regulation order prohibiting stopping, between 7 a.m. and 5 p.m., school days only, on the south side of Michigan Avenue, between Ford Boulevard and McDonnell Avenue, as established on April 19, 1982, East Los Angeles area (Supervisorial District 1).

5. Adopt a traffic regulation order prohibiting stopping, between 7:30 a.m. and 3 p.m., school days only, school buses excepted, on the south side of Michigan Avenue, between Ford Boulevard and McDonnell Avenue, East Los Angeles area (Supervisory District 1).
6. Adopt a traffic regulation order prohibiting parking anytime, on both sides of Harvest Avenue, between the south line of 166th Street and a point 290 feet southerly, Cerritos area (Supervisory District 4).
7. Adopt a traffic regulation order establishing stop control for northbound traffic on Avion Circle at Victoria Road, Castaic area (Supervisory District 5).
8. Adopt a traffic regulation order prohibiting stopping anytime, on the west side of Castaic Road, between the north line of Tapia Canyon Road and a point 1,760 feet northerly, Castaic area (Supervisory District 5).

#### **PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION**

Engineering investigations by Public Works revealed the removal or installation of traffic controls will improve traffic safety, enhance traffic flow, and better serve adjacent properties.

#### **Implementation of Strategic Plan Goals**

These recommendations are consistent with the County Strategic Plan Goal of Service Excellence as implementation of these actions will address and accommodate parking, traffic operations, and safety concerns of residents and motorists.

#### **FISCAL IMPACT/FINANCING**

Sufficient funds are included in the Public Works Road budget to cover the minor costs of removing and installing the necessary signs and markings. Financing is not required.

#### **FACTS AND PROVISIONS/LEGAL REQUIREMENTS**

The California Vehicle Code authorizes your Board to implement these traffic regulations, which are required prior to enforcement by the California Highway Patrol and Sheriff's Department.
