3 **REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF LOS**
4 **ANGELES TO RENDER SPECIFIED SERVICES TO THE CITY RELATING**
5 **TO THE CONDUCT OF A (PRIMARY) (GENERAL) MUNICIPAL**
6 **ELECTION TO BE HELD ON TUESDAY, APRIL 15, 2003 AND JUNE 3, 2003**

9 **THE CITY COUNCIL OF THE CITY OF COMPTON DOES RESOLVE AS**
10 **FOLLOWS:**

11 **SECTION 1.** That the City Council of the City of Compton does hereby find,
12 determine and declare as follows:

- 13 (a) That a Primary Nominating & General Elections will be held in said City April
14 15, 2003 and June 3, 2003; and
- 15 (b) That pursuant to law, certain election material must be prepared for mailing to
16 each registered qualified voter of said City prior to said elections; and
- 17 (c) That certain other election material must be obtained for said elections; and
- 18 (d) That the public interest, convenience and necessity requires that this City
19 Council request permission of the Board of Supervisor to allow the Registrar
20 of Voters of said County, to perform certain hereinafter specified services, for
21 and on behalf of said City in conjunction with said elections: and
- 22 (e) That the cost of said services, upon the completion thereof, shall be a proper
23 charge against the City.

24 **SECTION 2.** That the services requested by and on behalf of said City to be
25 performed by the said Registrar of Voter, shall be as follows:

- 26 (a) That pursuant to the provisions of Section 10002 of the Elections Code of
27 the State of California, this City Council hereby requests the Board of Supervisors of
28 said County to permit the Registrar of Voters to prepare and furnish to said City for
29 use in conducting said elections the computer record of the names and addresses of all
eligible registered voters in said City in order that the City may print labels to be
attached to selfmailer sample ballot booklets; and will also furnish to the City printed
indexes of the voters to be used by the Board at the polling place; and will make
available to the City additional election equipment and assistance according to state
law.

30 **SECTION 3.** That the City Clerk shall certify the adoption of this resolution
and shall forward certified copies hereof, to the Clerk of the Board of Supervisor, and
